- **Mandatory Vendor Meeting Thursday, May 10th at 5:30PM at Marine Park Shelter.**
- **Festival hours of operation are from 11AM-5PM on Saturday, May 12, 2018.**
- **Check-in begins at 8:30AM on Saturday, May 12th**
You will be assigned a table location which will be shared with you prior to the vendor meeting on May 10th. There will be limited vehicle access within 50' of the booths. *Please let us know any special considerations or needs in the Vendor Application form or email dherndon@jedc.org*
- **Each standard registration includes:** a covered space in an individual 10'x10' tent (or in a larger, shared tent), a table, and two chairs.
- **Electricity, extension cords, and running water are NOT included.** Special needs or accommodations should be noted in the space provided on the registration or emailed to Courtney at cnelson@jedc.org.
- **Breakdown and cleanup is immediately following the Festival, from 5:15PM -7:00PM on May 12th.** Starting at 5:15PM, tents and tables will be removed. **Vendors are asked not to breakdown their booths before 5PM.**
- The space assigned to you, including the tent space, table, and chair, are to be returned in the condition in which they were found. You are responsible for timely removal of materials.
- Registration of any and all exhibits, companies, or persons is wholly at the discretion of the Festival organizers. The Festival is all-ages and open to the public: do not bring items that may cause harm to children, live animals, or weapons of any kind.
- **Cancellations need to be made in writing via email or post.**
Refunds may be provided before May 4, 2018. No refunds for inclement weather.
- Late registrations may be accepted, depending on availability and at the discretion of Festival organizers.
