



STEM Summer Camp - Financial Aid Application

The Juneau Economic Development Council has a limited amount of funding for financial aid to those needing assistance. Aid is awarded based on household income and family size, using the chart below. **Aid will be awarded in the order complete financial aid applications are received** and approved *until scholarship funding is exhausted for the year*. *No person shall be denied or receive Financial Aid because of race, religion, national origin or sexual preference.*

All information provided will be maintained confidentially. **For the best chance of receiving Financial Aid, apply as soon as possible. You must pay the appropriate portion of camp fees at registration.** You will be notified by email if your application for financial aid is approved. If your application is not approved or approved for less than you requested, you must pay the balance of the camp fee when notified or you may cancel and request a refund. **The final deadline is 30 days before your camp starts at 5 PM Alaska Time for all completed Financial Aid Applications.**
